

SUMMER SCHOOL**Employment**

The Governing Board will approve a summer school program for the District, subject to the financial capabilities of the District, and establish an hourly rate of pay for the staff. Qualifications for summer school teachers will be the same as for regular full-time certificated employees. Teachers presently employed in the District will have preference for employment in the summer school program, providing application requirements are met.

The major consideration for employment will be the selection of the most capable applicants, according to guidelines. Where qualifications are equal, tenured teachers will be given preference.

Priority for summer school teaching positions shall be given to certificated personnel under contract to the Capistrano Unified School District for the ensuing school year and with teaching experience within the past three years in the subject area to be taught.

As much as possible, selection of staff for summer school sites will equally represent all school faculties in the district.

Notification of eligibility for employment does not guarantee a summer position for the teacher. Employment hinges upon a sufficient number of student enrollments to warrant offering the class in question. All applicants (selected and nonselected) will be notified as early as possible about the status of their applications.

The Governing Board recognizes that summer school provides valuable opportunities for students to improve their basic skills and make academic progress. To the extent that need is demonstrated and adequate funds are available, the Board may authorize the Superintendent or designee to establish summer school day and/or evening classes for purposes of remediation, enrichment, or acceleration.

At the elementary level, the District may offer instruction in any branches of study authorized and prescribed for elementary schools (Education Code 51730).

At the secondary level, the District shall provide all summer school offerings mandated by law (Education Code 37252).

Secondary classes also may be offered in mathematics, science, or other core academic areas designated by the Superintendent of Public Instruction (Education Code 37253).
