A bus pass application must be completed for each student. The Bus Pass Office will begin accepting applications June 3, 2024 for the 2024-25 school year. Applications MUST BE SUBMITTED NO LATER THAN 1:00pm on JUNE 28, 2024 to guarantee issuance before the first day of school. Applications will be processed in the order received, on a first come, first serve basis. Although the Transportation Department will make every effort to process each application and provide every student with a bus pass, some schools have very limited bus seating capacity available. Students who do not receive a pass due to over capacity will be placed on a wait list in the order received. Unfortunately, if an application is submitted after June 28, Transportation cannot guarantee a bus pass will be issued in time for the first day of school. Please make sure your child brings the bus pass to the bus stop every day. All applications are subject to bus stop review. *NOTE: CUSD does not provide bus service for School of Choice. Parents must transport.*
